

# Penn Township Recycling Site Agreement

## Guidelines and Regulations pertaining to utilization of the recycling site

Residents and Business Owners located within Penn Township are given the privilege to utilize the Penn Township Recycling Site during set hours. Certain regulations and rules must be met in order to maintain that privilege.

1. Authorized users of the Township's recycling site shall be restricted to residents and businesses located within Penn Township.
2. Upon payment of \$20.00 (twenty dollars) for residents and \$50.00 (fifty dollars) for businesses, Penn Township residents and business owners will be issued an annual pass (January 1 to December 31) which must be displayed by placing the placard on the driver's side dash of the user's vehicle when entering and exiting the Township recycling site.
3. Annual Passes are non-transferable.
4. Annual passes for recycling will be available at the Township Office located at 228 Clifford Road, Selinsgrove, during normal business hours. At the time of purchase, applicants will be required to furnish the Township Staff with the license plate number of the vehicle to be used to transport to the recycling site.
5. Use of the Township recycling site for any purpose if such person is not an employee or owner of a business located in or a resident living within Penn Township is prohibited.
6. Be sure to follow the directions of the Township's employees or authorized agents regarding use of the recycling site.
7. Open Monday through Friday from 7 am to 2 pm and the first Saturday of each month from 7 am to 2 pm.
8. The User has been granted a permit to use the Township's Recycling Center pursuant to the Township's Rules and Regulations. The User shall follow all Township's Rules and Regulations governing recycling. The User is aware that there is no guarantee that recycling will continue indefinitely. The Township reserves the right at its sole discretion to abandon or limit recycling; or change its rules and regulations at any time. Should the Township decide to limit or abandon recycling; or change its rules and regulations, the User is not permitted a refund for any permit issued.
9. The User further agrees to hold the Township harmless for any and all damages sustained by User, including personal injury or property damage, while using the Township's Recycling Center or as a result of the Township limiting or abandoning recycling.
10. Replacement costs will be assessed for any lost, stolen or damaged permit. Limit 2 replacements per year.

Failure to abide by the guidelines set forth above will result in loss of annual pass and suspended access to the site for one (1) year. Signature below acknowledges agreement with above outline of regulations and guidelines.
