Chairman Isaac Ramer Jr. called the 3.19.2025 Supervisor Meeting to order at 6:00 pm followed by the Pledge of Allegiance.

<u>Minutes</u> – On motion by Isaac Ramer, seconded by Ross Smoker, and Board acclamation to approve the March 5, 2025 supervisor's meeting minutes.

Persons Present to be Heard:

<u>Jason Kaufman, DH&L Fire</u> – Jason reported that there were thirty-three calls with no major fire loss. The tower truck is performing well. There are tickets available for purchase for their annual gun raffle. Instead of a banquet this year there will be a food truck coming to the station on the last Saturday in March to feed the crew.

<u>Brian Hipple, DH&L Ambulance</u> – Brian noted that there were two hundred and twenty-five calls with seventy-nine being in the township. No calls in the township this month were missed. They have four new members that are Susquehanna University students and they are already certified. All the units are currently in service and they have applied for a Community Foundation grant for equipment.

New Business:

Award Paving & Sealcoat Bids – The paving bids for work on Foxboro and Quarry Road were opened. On motion by Isaac Ramer Jr., seconded by Mark Strawser and Board acclamation to award the paving bid to New Enterprise Stone & Lime Company, Inc. in the amount of \$99,826.50 provided all bonds, certificates of insurance and other items required are supplied.

The sealcoating bids for Old 522 were opened. On motion by Isaac Ramer Jr., seconded by Mark Strawser and Board acclamation to award the sealcoating bid to Midland Asphalt Materials, Inc. in the amount of \$67,433.73 provided all bonds, certificates of insurance and other items required are supplied.

Batting Cage Construction at Field #4 – The East Snyder Regional Recreation Association recommended to the Board of Supervisors that the Little League be granted permission to erect a batting cage at field four behind the score board and along the first base line. On motion by Mark Strawser, seconded by Ross Smoker and Board acclamation to allow the Little League to construct a batting cage at field four.
