On motion by Jon Payne, second by Pete DeWire and acclamation of board to approve the application with the following conditions: Applicant must comply with all local, state and federal regulations; Applicant must comply with Section 825 of the Penn Township Zoning Ordinance; Applicant shall comply with the five factors in Penn Dot's Act 160, Chapter 6, (C)- Policy Applicable to Change of Message.{1. All messages/displays must remain unchanged for a minimum of five seconds. 2. The time interval used to change from complete message/display to the next complete message/display shall be a maximum of one second. 3. There shall be no appearance of visual dissolve or fading, in which any part of one electronic message/display appears simultaneously with any part of a second electronic message/display. 4. There shall be no appearance of flashing or sudden bursts of light, and no appearance of animation, movement of flow of the message/display. 5. Any illumination intensity or contrast of light level shall remain constant.}; Message display of "public events" or "community events/services" shall also follow the "not less than five second" change rate as detailed above for any other message/display, per Penn Dot's Act 160.
