New Business:

<u>Comfort Station Bid Award</u> – Art Thomas of Meck-Tech went over the bid tabulations with the Board of Supervisors noting each low bid in each category. After discussion the following motions were made:

Construction, in the amount of \$147,700.00. On motion by Isaac Ramer Jr., seconded by Ross Smoker, and Board acclamation to reject all bids on the electrical because electrical without alternate one will be donated.

On motion by Isaac Ramer Jr., seconded by Ross Smoker, and Board acclamation to award the plumbing bid contract to the low bidder, D.B. Construction, in the amount of \$44,800.

Old Business:

<u>Parking Lot Barriers at ESP</u> – Isaac shared that he did some research and pricing on concrete barriers but the cost was very high so he recommended that the Roadmaster research the cost of 6x6 treated posts with cables.

<u>ESP Mower Discussion</u> – After some discussion it was decided that the subject would be tabled until October before the budget meetings start. Isaac requested that the road crew get the mowers being considered and demo them at the park so a more informed decision could be reached. **On motion by Isaac Ramer Jr., seconded by Ross Smoker, and Board acclamation to table the decision until mowers are demonstrated by the road crew in the fall.**
