Chairman Jon Payne called the 8.15.2018 Supervisor Worksession Meeting to order, 6:00 pm, followed by the Pledge of Allegiance.

On motion by Brenda Moyer, second by William Moyer and board acclamation to close Conditional Use Hearing at 6:30 pm.

Chairman Jon Payne called the 8.15.2018 Supervisor's Worksession Meeting to reconvene at 6:32 pm.

On motion by William Moyer, second by Jon Payne and board acclamation, Brenda Moyer abstained, to approve the August 1, 2018 Supervisors regular meeting minutes with the following corrections:

Persons Present to be Heard:

<u>Glenda Ruch, SEDA-COG</u> – Glenda informed the Board that after surveying Sunset Drive, Pleasant Drive and Fairview Drive; these areas will not qualify for a CBDC project. She then asked the Board if they would like to see the funding used for the Housing Rehabilitation Program for low to moderate income families within Penn Township. There are currently seven residents on the waiting list from the township. There is \$76,353 available to help these residents. SEDA-COG would handle all research and paperwork involved with the project.

On motion by Jon Payne, second by William Moyer and board acclamation to have a special meeting with Mike Fisher of SEDA-COG to discuss the housing rehabilitation program.

<u>LTAP Winter Maintenance Training</u> – LTAP training will be held in State College on September 17, 2018 for winter maintenance with no fee to attend. On motion by Brenda Moyer, second by Jon Payne and board acclamation to send all new employees and the Roadmaster to the LTAP Winter Maintenance Training on 8.17.2018.

<u>Safety Manual</u> - On motion by Brenda Moyer, second by Jon Payne and board acclamation to adopt the new Safety Manual.

<u>Part-time Secretary</u> – Interviews were held today, August 15, 2018 at 2:30 pm for the position of part-time township secretary. On motion by Jon Payne, second by William Moyer and board acclamation to hire Rebecca Boop as part-time Township Secretary at a rate of \$14.00 per hour, not to exceed twenty hours per week.
