## Penn Township Supervisor Workshop Minutes April 20, 2016

Chairman Pete DeWire called the 4.20.2016 workshop to order 6:00 pm, followed by the Pledge of Allegiance.

Present included: Supervisors: Pete DeWire, Brenda Moyer and Jon Payne, Solicitor James Bathgate

Three signatures were not legible.

On motion by Jon Payne, second Brenda Moyer and board acclamation the April 6, 2016 Zoning Hearing Minutes were approved with the following correction.

### **Public Comment**

Zoning Hearing Board member Joe Dubaskas, asked that the hearings minutes of 4.6.2016 be reopened to add clarification under the public comment sections to include: Mr. Dubaskas' to be included as part of the conversation with Mr. Ken Herman Sr. to consider stepping down from the ZHB was because of concerns over Mr. Herman's mental and physical condition. Mr. Herman did contact the Township stating that he would step down. On motion by Jon Payne, second by Brenda Moyer and board acclamation the 4.6.2016 hearing minutes will be revised as such.

On motion by Jon Payne, second Brenda Moyer and board acclamation the April 6, 2016 regular meeting minutes were approved with the noted revision.

<u>Jan Ritter</u> – Ritter read from prepared notes, Ritter noted Supervisor Moyer wrote the nuisance ordinance that has been a point of contention in the twp, Moyer was also accused of trying to pass the ordinance behind the backs of the residents. (proposed ordinance had been properly advertised). Supervisor Moyer was accused of working to change the zoning map and the zoning ordinance. Ritter noted as many eight employees have left Penn Township and Supervisor Moyer was the reason. Ritter stated zoning officers have left. <u>Bill Moyer</u> – Moyer stated four (4) lives have been ruined accusing employee Brenda Moyer of being responsible for these ruined lives.

<u>Bill Kline</u> – Kline had written information and stated Supervisor Moyer could not work with Union Township Supervisors either. Moyer questioned this and Kline insisted Moyer had interaction with these Supervisors the previous week and they could not work with Moyer. Moyer questioned Kline's accusations and denied this.

Mr. Kline also accused Pete DeWire of making township comments at Dunkin' Donuts and would provide more details at the next meeting.

<u>Lisa Geisen</u> – Geisen accused Supervisor Moyer of giving her the run around in an attempt to get a zoning permit. Moyer explained she had not done this but had actually tried to get the zoning officer to resolve the permit situation with Geisen. Geisen spoke of a day she came to the township to find out where her permit was and stated Supervisor Moyer continued to give her the run around. Moyer noted the zoning officer stood (hid) in the meeting room and did not come out to face Geisen and explain that her application did not meet the township zoning regulations.

Geisen also brought up letters prepared by Supervisor Moyer in 2014 with regard to nuisance issues on some properties.

<u>Dana VanHorn-Teats</u> – Teats read from a prepared statement also accusing the Township and specifically Supervisor Moyer of many things: no training provided, being micromanaged, asking Teats to delete items from the minutes, watching employees restroom use on the surveillance cameras and telling Teats how to use the delete key when Teats knew how to use the delete key. Teats was unaware she could be seen on the surveillance cameras and questioned why she was not informed. Moyer tried to rebut the allegations made by Teats but was stopped by Chairman DeWire and the solicitor.

<u>Joe Dubaskas</u> – Joe <u>Dubaskas</u> commented he was happy to have Mr. Slivinski as the ZHB solicitor contrary to rumor. Dubaskas accused Supervisor Moyer of telling someone at Wal-Mart Dubaskas was not in favor of Cravitz being removed as Zoning Hearing Board Solicitor and replaced with Bob Slivinski. Supervisor Moyer had no idea what Dubaskas was talking about. Dubaskas accused Supervisor Moyer of changing the meeting day of the recreation board meetings in 2005ish to exclude Dubaskas from attending the meetings as Moyer knew he was unavailable on the new meeting day. Moyer questioned what he was talking about, denied the accusation and questioned the relevance in 2016.

<u>Ken Teats</u> – Teats stated his wife could work with anyone and was surprised she could not work with Supervisor Moyer. Teats informed Supervisor Moyer there are people in the Township who would not brake or stop but would run over Supervisor Moyer if she were standing in the road.

Residents immediately complained that Teats was making personal threats and called for control of the meeting.

The board reconvened at 6:50 PM with no official action taken in the executive sessions.

It was stated by the Solicitor and Supervisor Payne, a Supervisor may volunteer.

Jan Ritter presented to the Board her Statement of Financial Interest.

Joe Dubaskas commented he was happy to have Mr. Slivinski as the ZHB solicitor contrary to rumor.
