PENN TOWNSHIP MINUTES January 6, 2014

The Penn Township Board of Supervisors held their Year 2014 Re-organization meeting on Monday, January 6, 2014 at the Municipal Building, 228 Clifford Road, Selinsgrove, Snyder County, Pennsylvania. Temporary Chairman Jon Payne called the meeting to order at 7:00PM. Supervisors present: Fred Ulrich; Brenda Moyer; Jon Payne. Others present: Robin Bieber; Robert Muolo. Members of the Public: Isaac Ramer Jr; Darwin Swope; Samantha Moyer; Lynn Whitten, Community Aid.

APPOINTMENT OF CHAIRMAN

Temporary Chairman Jon Payne called for nominations for Chairman. Fred Ulrich was nominated upon motion by Brenda Moyer, seconded by Jon Payne. Nominations were closed upon motion by Brenda Moyer, seconded by Jon Payne. By unanimous vote, Fred Ulrich is Chairman. Chairman Ulrich called for nominations of Vice-Chairman. Jon Payne was nominated upon motion by Brenda Moyer, seconded by Fred Ulrich. Nominations were closed upon motion by Brenda Moyer, seconded by Jon Payne. By unanimous vote, Jon Payne is Vice-Chairman.

PLEDGE OF ALLEGIANCE

APPROVAL OF MINUTES

The minutes of the December 4, 2013 meeting were approved as presented upon motion by Jon Payne, seconded by Fred Ulrich, with Brenda Moyer abstaining. Motion passed. The minutes of the December 18, 2013 workshop were approved as presented upon motion by Jon Payne, seconded by Fred Ulrich, with Brenda Moyer abstaining. Motion passed.

PUBLIC COMMENT

No Public Comment was heard at this time.

PERSONS PRESENT TO BE HEARD

Lynn Whitten, Community Aid, was present with information on a Community Aid bin that they would like to install by the recycling center. Ms Whitten explained that Community Aid is a faith-based not-for-profit organization which is opening a thrift store in the former Value City building. The bin will be for clothing only and will be removed within 48 hours if there is a problem. Ms Whitten also explained that any organization or business who places a bin on their property becomes a partner and receives four cents per pound of material collected. After discussion, motion made by Jon Payne, seconded by Brenda Moyer and unanimously approved, to allow a Community Aid bin to be installed at the recycle center with the understanding that it will be removed if there are any problems.

Concerning the garage ceiling project, upon motion by Fred Ulrich, seconded by Brenda Moyer and unanimously approved, the DB Construction Letter of Credit will be reduced by \$6,000 contingent upon the materials being stored at the Penn Township Municipal Building, and receipt of paid invoices. Remaining balance shall be \$7,400.00.

Solicitor Robert Muolo reported on the ordinance currently being drafted regarding parking on township roads during snow events, and suggested combining this ordinance with an ordinance to remove all obstacles from the township right-of-way. Notification during snow or other events would be upon decree of a weather advisory issued by the Supervisors or Roadmaster and would be sent to radio stations and put on the Township website.

The Old Colony Road speed study will be reviewed in depth and discussed at the workshop meeting which will be held on January 15, 2014.

Secretary Robin Bieber reported that although the fire hydrant on Gaugler Lane is not in working order, the residents of Gaugler Lane pay hydrant tax because they are within the designated radius for a fire hydrant on State School Road.

The Jackson Township snow plowing agreement was signed.
