The September 25, 2017 regular meeting of the Planning Commission was called to order at 7:03 by Vice Chairman, Jim Wentzel.

On motion by Derek Straub, second Ken Herman Jr., and acclamation, the minutes of the August 28, 2017 Planning Commission regular meeting, were approved as presented.

On motion by Ken Herman Jr., second Tim Moyer and acclamation the minutes of the September 11, 2017 Planning Commission Worksession were approved as presented.

Public Comment - n/a

Persons Present to Be Heard -

Bob Bickhart, PLS was present representing the Johnnie E. Herman and Stephen Rehrer Lot Add On Plan. This plan is a reconfiguration of Tax Map PN's 13-02-009 (Herman) and 13-02-040 (Rehrer) along with a revised easement for access to Tax Map PN 13-02-005 (Rehrer). This revised easement shall run solely on the TAX MAP PN 13-02-040 (Rehrer) until it reaches Tax Map PN 13-02-105 (Rehrer).

As shown on the plan, Johnnie E. Herman shall convey 183 sq ft to adjoining lot owner Stephen Rehrer. Adjoining lot owner Stephen Rehrer shall convey to Johnnie E. Herman two lots, one 5683 sq ft and one 10792 sq ft. The purpose of the reconfiguration is to create a more uniform boundary line. No utilities are proposed nor any development and the request does meet the ordinance requirements for the AC zone. SCPC comments were reviewed.

On motion by Tim Moyer, second Derek Straub and acclamation the PC do recommend, with proper certification by landowners provided on the Plan, the BOS do approve this Add On Lot Plan as proposed by Johnnie E. Herman and Stephen Rehrer.
