## ORDINANCE NO. 2016-02

AN ORDINANCE OF PENN TOWNSHIP, SNYDER COUNTY, PENNSYLVANIA, ADOPTING AND APPROVING AN AMENDMENT TO THE ARTICLES OF INCORPORATION OF PENN TOWNSHIP MUNICIPAL AUTHORITY, AS PROPOSED BY RESOLUTION OF THE BOARD OF SAID AUTHORITY; SETTING FORTH THE PROPOSED AMENDMENT; AUTHORIZING THE AUTHORITY AND PROPER OFFICERS THEREOF TO EXECUTE, VERIFY AND FILE APPROPRIATE ARTICLES OF AMENDMENT; AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT THEREWITH.

WHEREAS, Penn Township Municipal Authority (the "Authority") is a municipality authority incorporated and existing under the Pennsylvania Municipality Authorities Act of 1945, approved May 25, 1945, P.L. 382, as amended and supplemented (the "Authorities Act"), pursuant to appropriate action of the Board of Supervisors of the Township of Penn, Snyder County, Pennsylvania (the "Township"); and

WHEREAS, The Authority, by resolution duly adopted, has proposed that its Articles of Incorporation shall be amended so as to increase its term of existence, which amendment is authorized and permitted by the Authorities Act; and

WHEREAS, The Authority has caused to be submitted to the Board of Supervisors of this Township a copy of the resolution adopted by the Board of the Authority, duly certified by the Secretary of the Authority, wherein said amendment is proposed, which resolution contains the language of said proposed amendment; and

WHEREAS, The Authorities Act provides, inter alia, that the Board of Supervisors of this Township, being the governing authority of the municipality composing the Authority, shall adopt or reject said proposed amendment by resolution or ordinance.

NOW THEREFORE, BE IT ENACTED AND ORDAINED, by the Board of Supervisors of this Township, as follows:

Section 1. The Board of Supervisors of this Township adopts and approves the amendment to the Articles of Incorporation of the Authority, as proposed by a resolution duly adopted by the Board of the Authority, a copy of which resolution, duly certified by the Secretary of the Authority, has been submitted to the Board of Supervisors of this Township.

Section 2. The amendment to the Articles of Incorporation of the Authority, which is adopted and approved, shall provide that the following paragraph shall be added to said Articles of Incorporation:

(f) The term of existence of Penr	n Township	<b>Municipal Authority</b>
shall be for a period ending on $\_$	0-1-	, 2066;

Section 3. Proper officers of the Authority are authorized to execute, verify and file appropriate Articles of Amendment with the Secretary of the Commonwealth of Pennsylvania and to take all other action and do all other things which may be necessary in order to accomplish the amendment of the Articles of Incorporation of the Authority in the manner herein adopted and approved.

Section 4. All Ordinances or parts of Ordinances, insofar as the same shall be inconsistent herewith, shall be and the same expressly are repealed.

In compliance with requirements of the Pennsylvania Municipality Authorities Act of 1945, approved May 2, 1945, P.L. 382, as amended and supplemented, and pursuant to a resolution duly adopted by the Penn Township Municipal Authority, proposing an amendment to the Articles of Incorporation of the Authority, which proposed amendment has been submitted to and adopted and approved by the Board of Supervisors of the Township of Penn, Snyder County, Pennsylvania, the governing authority of the municipality composing the Authority, by an Ordinance duly enacted, the Authority does file these Articles of Amendment to its Articles of Incorporation and does certify:

- 1. The name of the Authority is "Penn Township Municipal Authority"; and the registered office of the Authority is located at 2595 Route 522, Suite 10, Selinsgrove, Pennsylvania, 17870.
- 2. The Articles of Incorporation are recorded in the Department of State of the Commonwealth of Pennsylvania at 3-1-69.26,689 to 693, inclusive.
- 3. The amendment proposed by the Board of the Authority and adopted and approved by the Board of Supervisors of the Township of Penn, Snyder County, Pennsylvania, as aforesaid, is to amend the Articles of Incorporation of the Authority by the addition thereto of the following paragraph:

- 4. If the Board of Supervisors of the Township shall duly adopt and approve the amendment of the Articles of Incorporation of this Authority, as proposed in this Resolution, the Chairman or Vice Chairman of this Authority are authorized and directed to execute and verify Articles of Amendment, substantially in the form set forth in Paragraph 2, and the secretary or Assistant Secretary of this Authority is authorized and directed to affix thereto and attest the official seal of this Authority.
- 5. If the Board of Supervisors of the Township shall duly adopt and approve the amendment of the Articles of Incorporation of this Authority, as proposed in this Resolution, the Chairman or Vice Chairman and Secretary or Assistant Secretary of this Authority authorized and directed to advertise, in the manner specified in and required by the Authorities Act, the intention of this Authority to file Articles of Amendment with the Secretary of the Commonwealth.
- 6. If the Board of Supervisors of the Township shall duly adopt and approve the amendment of the Articles of Incorporation of this Authority, as proposed in this Resolution, the Chairman or Vice Chairman and Secretary or Assistant Secretary of this Authority are authorized and directed to cause the Articles of Amendment, together with the necessary proofs of publication, to be filed with the Secretary of the Commonwealth of Pennsylvania and to do all other acts and things necessary or appropriate to secure approval of the Articles of Amendment, including payment of filing fees and charges required in connection therewith.
- 7. All resolutions or parts of resolutions, insofar as such shall be inconsistent herewith, shall be and the same expressly are repealed.
