# **APPROVAL OF MINUTES**

The minutes of the June 21, 2011 meeting were approved as presented upon motion by Fred Ulrich, seconded by Bill Moyer, and approved.

# **PUBLIC COMMENT**

No Public Comment was heard at this time.

### **PERSONS PRESENT TO BE HEARD**

Robert Bickhart, Gerald E Bickhart & Sons, presented the Rick & Cyndi Romig Sub-Division located on Route 204, the former Susquehanna Valley Mechanical Contractors location. This sub-division separates Lot#1 (1.1164 acres) with existing house, and Lot#2 (10.022 acres), which contains the well that supplies water to Lot#1, recorded agreement as such in the Snyder County Courthouse. Also, a shared driveway per the included declaration, which shall be recorded with the sub-division plan. After review, motion was made by Fred Ulrich, seconded by Bill Moyer and approved, to approve the Rick & Cyndi Romig Sub-Division as presented, the driveway declaration, and the Sewage Facilities Planning Module. Motion passed.

Jessica Stover, resident of Beaver Road, was present with concerns of the washout of the Township maintained swale above her property which washed many large rocks and stones onto her property with the recent storms. After lengthy discussion, the road crew will remove the stones from the ditch, and repair the swale, using asphalt as necessary, and will spread grass seed on Stover's property to repair the lawn. This upon motion by Fred Ulrich, seconded by Bill Moyer and approved.

#### **REPORTS**

Roadmaster Bill Moyer provided a written report on recent activities, and reported on damage from recent storms.

Tom Snyder, Zoning Officer, provided a written report. 28 zoning permits y-t-d.

Robin Bieber, Township Secretary, reported there are still currently twp dumpsters at the ESP, one being emptied twice per week. Once activity at the park slows, that dumpster will go back to once per week pick up. Also, Robin asked for an Executive Session.

\*\*Executive Session was called at 7:24PM. Meeting continued at 7:36PM. Discussion held on personnel issues and interview processes with no official action taken.

Emergency Management Coordinator Fred Ulrich reported on some of the damages from recent storms. One traffic signal was damaged from lightning. Streams were up with flash flooding.

Upon motion by Fred Ulrich, seconded by Bill Moyer and approved, Solicitor James Bathgate will be authorized to review the draft of the Penn Township Zoning Ordinance.

After discussion on the drain system at ESP that has failed, Fred Ulrich will gather prices for a pump station with grease traps.
